

First Battery Centre “Win a Car” Competition Rules

In these Competition Rules, the following definitions apply (unless the context clearly indicates otherwise):

“the Act” means the Consumer Protection Act, No. 68 of 2008.

“Business Day” means any day other than a Saturday, Sunday, or a proclaimed public holiday in the Republic of South Africa.

“Competition Rules” means these rules as required by Section 36 of the Act.

“Competition” means the First Battery Centre “Win a Car” Promotional Competition, in terms of which Participants stand a chance to win a car when they purchase an automotive battery from a Participating Store during the Promotion Period.

“Participant” means any natural person who enters the Promotional Competition and meets the criteria set out in these Rules.

“Participating Store” means any official First Battery Centre store located in the Republic of South Africa.

“POPI” means the Protection of Personal Information Act, No. 4 of 2013.

“Promoter” means First National Battery Division of Methodustrial (Pty) Ltd and/or its agencies, also referred to as the “Organisers”.

“Promotional Competition” means the competition conducted by the Promoter during the Promotion Period in accordance with these Competition Rules.

“Promotion Period” means the period commencing 20 March 2026 and ending on 31 August 2026. No late entries will be accepted.

“Prize” means the car described below.

“Redeemable Period” means the period within which the Prize must be claimed, being 30 calendar days from the date the Winner is notified, failing which the Prize will be forfeited.

“Winner” means a Participant who is successful in the Promotional Competition and is notified as such by the Promoter.

The Promoter is offering a Promotional Competition in terms of which Participants may enter the competition for a chance to win the Prize, subject to these Competition Rules.

Consumer Protection Act Notice

The Competition Rules contain certain terms and conditions which may:

- limit the risk or liability of the Promoter or a third party;
 - create risk or liability for the Participant;
 - compel the Participant to indemnify the Promoter or a third party; or
 - serve as an acknowledgement of certain facts by the Participant.
- Participants are advised to read these Competition Rules carefully.

Eligibility of Participants

To participate in this Competition, the Participant must:

- be a natural person (juristic persons are excluded);
- be 18 years or older; and
- be a permanent resident or citizen of the Republic of South Africa.

By entering the Competition, the Participant acknowledges that they have read and understood these Competition Rules and agree to be bound by them. Participation in the Competition is entirely at the Participant's own risk. Directors, employees, agents, consultants of the Promoter and their immediate family members, spouses, life partners, or any supplier associated with this Competition may not participate.

How to Enter

To enter the Competition, Participants must:

- Purchase any automotive battery from a participating First Battery Centre store during the Promotion Period.
- Register the battery warranty in-store.
Once the warranty registration has been successfully completed, the Participant will automatically be entered into the draw for a chance to win the grand prize.
Entries that are unclear, incomplete, or contain errors will be deemed invalid. No entry will be valid until it has been verified through a validation process determined by the Organisers.

The Prize

One (1) winner will be selected through an audited random draw on 1 September 2026. The Winner will receive one car as the grand prize.

Promotional material depicting the Prize constitutes a representation of the Prize, and the actual Prize awarded may differ in appearance.

The Promoter reserves the right to substitute the Prize with another prize of similar commercial value should circumstances beyond their control require it.

The Winner will be contacted via WhatsApp or telephone within 21 calendar days of the draw.

If the Promoter is unable to contact the Winner after reasonable attempts, the Promoter reserves the right to select an alternative Winner.

The Winner may be required to collect the Prize from a participating First Battery Centre branch.

Any Prize not claimed within 30 days of notification will be forfeited. The Prize is not transferable, exchangeable for cash, or negotiable.

Winner Announcement and Publicity

One (1) Winner will be selected at the end of the Promotion Period through an audited draw supervised by an independent person appointed by the Promoter.

By participating, the Winner agrees to reasonable promotional publicity related to the Competition, which may include photographs with the Prize, promotional campaigns, and social media posts on platforms such as Instagram, Facebook, or the Promoter's website.

The Winner may be required to provide full name, ID number, address, and contact details, and to sign an acknowledgement of receipt of the Prize.

Participants consent to the Promoter using personal information collected through the Competition for administering the Competition, contacting the Winner, and future marketing communications.

Participants may opt out of future marketing at any time.

General Rules

Entry into the Competition does not guarantee winning. Winners will be selected through an audited random draw. Participants must provide accurate and up-to-date personal information. The Promoter reserves the right to amend these Competition Rules if necessary and will communicate such amendments within a reasonable period.

The Promoter may terminate or suspend the Competition at any time due to circumstances beyond its control, including natural disasters, pandemics, travel restrictions, or other force majeure events. In the event of a dispute, the Promoter's decision will be final and binding. Any fraudulent or dishonest conduct may result in immediate disqualification.

Indemnification

Participation in the Competition and acceptance of the Prize is entirely at the Winner's own risk.

By entering the Competition, Participants agree to indemnify and hold harmless the Promoter and its partners, employees, and agents from any liability arising from participation, acceptance, or use of the Prize, including personal injury, property damage, or other losses.

Prize Qualification Rules

A Prize will not be awarded if:

- it is prohibited by law for the Winner to receive or use the Prize;
- the Winner is a director, employee, agent, or consultant of the Promoter;
- the Winner is a supplier involved in this Competition.

The Winner must provide valid proof of identity (ID document, passport, or driver's licence) when claiming the Prize.

The Prize is not transferable, exchangeable for cash, or negotiable. Any costs not expressly included in these Rules, including licensing, insurance, or other vehicle-related costs, will be for the Winner's account.

Failure to provide valid proof of purchase or identity may result in forfeiture of the Prize.

POPI Compliance

Any personal data collected from Participants will be processed in accordance with the Consumer Protection Act and the Protection of Personal Information Act (POPIA).

Participant information will only be used for administering the Competition and related marketing purposes, and will not be shared with third parties without consent unless required by law.

This promotion is not sponsored, endorsed, administered by, or associated with Facebook, Instagram, or any other social network.

By entering the Competition, Participants consent to their personal information being shared with the Promoter's employees, contractors, or agents for the purpose of administering the Competition.
