

First Battery Centre “Win a Car” and “Win R500 in fuel vouchers” Competition Rules

Definitions

“Competition” means the First Battery Centre Promotional Competition conducted by the Promoter, consisting of various promotional campaigns, including the “Win a Car” Competition and the “Win R500 Fuel Voucher” Competition, each with its own promotional period, mechanics and prize structure.

“Prize” means either the vehicle awarded in the “Win a Car” Competition or the fuel voucher awarded in the “Win R500 Fuel Voucher” Competition.

“Promotion Period” means the overall First Battery Centre promotional campaign period commencing on 1 June 2026 and ending on 31 December 2026. During this period, the Promoter may run smaller promotional competitions, each with its own specific promotional period, entry mechanics, closing dates, and prizes.

The Promoter reserves the right to amend promotional periods, competition dates, requirements, mechanics or any other aspect of the Competition at its discretion where reasonably necessary. Any material amendments will be communicated within a reasonable period.

Promotional Campaign Periods

Win R500 Fuel Voucher Competition

The Fuel Voucher Competition will run from:

15 June 2026 until 31 August 2026.

A total of 105 winners will be selected during this period.

The fuel voucher draw will take place at the end of the competition, on 1 September 2026.

Win a Car Competition

The Win a Car Competition will run until:

31 August 2026.

One (1) winner will be selected through an audited random draw.

The draw date is currently scheduled for:

1 September 2026

However, the Promoter reserves the right to amend the draw date where necessary.

Eligibility of Participants

To participate in the Competition, Participants must:

- Be 18 years or older
- Be a South African citizen and permanent resident residing in South Africa only
- Hold a valid South African driver's licence
- Purchase a qualifying First Battery manufactured battery from a participating First Battery Centre store during the applicable promotional period
- Register the battery warranty successfully in-store
- Retain valid proof of purchase and warranty registration confirmation, which may be requested by the Promoter for verification purposes

Purchases of batteries manufactured by any other brand will not qualify for entry.

Only one entry per customer is permitted for the Competition, regardless of the number of qualifying batteries purchased.

Employees, directors, agents, consultants, suppliers involved in the Competition, and their immediate family members may not participate.

How to Enter

To enter:

1. Purchase a qualifying First Battery manufactured battery from a participating First Battery Centre store during the relevant promotional period
2. Complete the battery warranty registration process in-store
3. Once the warranty registration has been successfully completed, the Participant will automatically be entered into the applicable draw

Participants must retain their proof of purchase and warranty registration confirmation.

Entries that are incomplete, inaccurate, fraudulent or cannot be validated will be deemed invalid.

The Prize

Car Prize

One (1) winner will receive:

A Toyota Starlet 2026 model vehicle valued at approximately R300,000* (Three Hundred Thousand Rand)

The Prize includes the vehicle only.

The following costs are excluded and will be for the Winner's own account:

- Insurance
- Maintenance
- Fuel
- Any additional costs associated with ownership or use of the vehicle.

The Promoter reserves the right to substitute the vehicle with another vehicle of similar commercial value should circumstances beyond its reasonable control require such substitution.

Fuel Voucher Prize

One hundred and five (105) winners will each receive:

A fuel voucher valued at R500 (five hundred Rand).

Fuel vouchers will be issued digitally via a Sasol digital fuel card.

Winners will be required to:

1. Download their digital Sasol card via the Sasol App
2. Share their digital card details via WhatsApp to the official WhatsApp number provided in the winner notification message.

The Winner must provide the required details within 5 calendar days from the date on which they are notified of their win.

Failure to provide the required details within this period may result in the prize being forfeited.

Winner Selection

The car winner and fuel voucher winners will be selected through an audited random draw process.

- One (1) Car Winner will be selected on or about 1 September 2026
- One hundred and five (105) Fuel Voucher Winners will The fuel voucher draw will take place at the end of the competition, on 1 September 2026

The Promoter reserves the right to adjust draw dates where operational circumstances require.

Winner Notification and Prize Claim

Winners will be contacted using the contact details provided during entry.

The Promoter will make reasonable attempts to contact successful Winners.

If a Winner cannot be contacted after reasonable attempts, fails to provide required information, or does not comply with the Competition Rules, the Promoter reserves the right to select an alternative Winner.

Redeemable Period

The Redeemable Period means the period within which the Prize must be claimed.

For the Car Prize, the Winner must claim the Prize within 30 calendar days from the date on which they are notified of their win. Failure to claim the Prize within this period will result in the Prize being forfeited, and the Promoter reserves the right to deal with the Prize at its discretion.

For the Fuel Voucher Prize, Winners must provide their valid digital Sasol card details via WhatsApp within 5 calendar days from the date on which they are notified of their win. Failure to provide the required details within this period may result in the Prize being forfeited.

Additional Recommended Clauses

No Correspondence

No correspondence will be entered into regarding the Promoter's decisions, draw results, or selection of Winners. The Promoter's decision regarding any aspect of the Competition shall be final and binding.

Winner Descriptors

- The winner will be contacted directly using the contact details provided when entering the competition
- The winner will be required to verify their details and eligibility before the prize can be awarded
- The winner will be required to travel from their place of residence to Johannesburg to facilitate the prize handover – promoter will cover the costs
- Travel and logistics arrangements will be confirmed directly with the winner once the winner has been verified
- The winner may be required to provide the necessary documentation to confirm their identity and eligibility.

Winner Content & Publicity

The winner will be required to participate in photography, videography and/or interviews relating to the competition and prize handover

Videos/images captured will be used across the brand's social media channels, digital platforms and other campaign collateral.

Winner Notification(Fuel)

The winner will be contacted using the contact details provided at the time of entry, which may include telephone, WhatsApp and/or email.

The winner will be given 3–5 business days to respond, subject to the timeframe stipulated in the competition Terms & Conditions.

If the winner cannot be reached, fails to respond within the stipulated timeframe, or does not meet the eligibility requirements, an alternative winner will be selected in accordance with the competition Terms & Conditions.

Winner Verification Documentation

The winner will be required to provide the necessary verification documentation within 5 (five) working days of being notified of their win. This documentation must include, but is not limited to:

- A certified copy of the winner's South African ID or valid passport
- A valid driver's licence
- Proof of residential address
- Any additional documentation reasonably required by the Promoter to verify the winner's identity and eligibility.

The Promoter reserves the right to request additional documentation where reasonably necessary to verify the winner's identity and eligibility. Failure to provide the required documentation within the stipulated 5 (five) working days may result in the winner being disqualified and an alternative winner being selected, subject to the applicable competition terms and conditions.
